

**4-H Council Meeting**  
**Monday, October 29, 2018**  
**7 PM @ the Extension Office**

The bi-monthly meeting of the Kingman County 4-H Council was called to order by President Abby Flickner, on Monday, October 29, 2018 at 7 PM at the Kingman County Extension Office.

Roll Call was answered by 10 members, 9 leaders and 2 agents. The minutes of the previous meeting were read by acting secretary, Taylor Schultz. A motion was made by Cherielle Young to approve the minutes as read. Nolan Roth seconded the motion. Motion passed.

**Election of Officers:**

President, Abby Flickner, opened the floor for nominations for the 2018-2019 program year for the 4-H Council officer slate. Taylor Schultz was nominated by Cami McAndrew. A motion was made by Judy DeWeese to cease nominations. Motion seconded by Nolan Roth. Motion Passed. Gail Flickner moved to cease nominations and cast a unanimous ballot. Nolan Roth Seconded. Motion passed, and ballot approved. Delaney Arensdorf moved to nominate Riley Dick as the Secretary. Cherielle Young moved to cease nominations and cast a unanimous ballot. Brant Floyd seconded. Motion passed, and ballot approved. Lynette Allender moved to nominate Nolan Roth as Treasurer. Cami McAndrew seconded. Gail Flickner moved to cease nominations and cast a unanimous ballot. Motion passed, and ballot approved. Your 2018-2019 Kingman County 4-H Council officers are: President- Taylor Schultz, VP- Delaney Arensdorf, Secretary- Riley Dick, and Treasurer- Nolan Roth.

President Taylor Schultz took over the meeting as acting president.

The treasurer's report was read by Taylor Schultz. The checking account balance is \$18, 77878, savings balance is \$565.79. Ambassadors balance is \$1,937.50, Exchange balance is \$743.82, and the Gillen Memorial balance is \$3,079.00. Jamie Belt moved to approve the treasurer's report as read. Nolan Roth seconded the motion. Motion passed.

**National 4-H Week-** Hawk went to 4-H Sunday and put up signs at the school as well as a window display at Aarons. Vinita had a 4-H display at Citizens State Bank and handed out flyers with candy that included both Kingman and Sedgwick County 4-H Club information on them. Cunningham had a 4-H display at the Elementary School and also had a boy and girl go around to the classrooms and talk to them about the 4-H Program. Whispering Willow had a display at Floyd Auction and helped with morning announcements at the schools throughout the week.
